THIS PERMIT IS VALID FOR 72-HOURS OR 3 CALENDAR DAYS FROM THE EFFECTIVE DATE AND TIME INDICATED, ONLY FOR THE VEHICLE DESCRIBED HEREIN. PERMIT IS NOT TRANSFERABLE TO ANY OTHER PERSON, COMPANY OR VEHICLE. DATE OF ISSUANCE MAY NOT BE MORE THAN 5 DAYS PRIOR TO THE EFFECTIVE DATE. OPERATIONS MAY NOT TAKE PLACE UNTIL THE EFFECTIVE DATE AND TIME. PERMIT MUST BE CARRIED IN THE VEHICLE AND EXHIBITED UPON DEMAND OF LAW ENFORCEMENT. THIS PERMIT IS FOR ONE TRIP IN AND/OR OUT, ONE ROUND TRIP, OR ONE TRIP THROUGH THE STATE OF ILLINOIS. PERMIT CANNOT BE USED FOR MULTIPLE TRIPS. NO REFUNDS AFTER ISSUANCE OF PERMIT. CERTAIN VEHICLES ARE ELIGIBLE FOR POINT-TO-POINT USE IN ILLINOIS WITH THIS PERMIT (CARNIVAL OR 72-HOUR INTRASTATE). NO MORE THAN 3 TRIP PERMITS MAY BE ISSUED TO THIS VEHICLE IN ANY 12-MONTH PERIOD. THIS PERMIT CANNOT BE ISSUED ON ANY VEHICLE REQUIRED TO BE REGISTERED IN LIEU OF REGISTRATION FEES. VALID REGISTRATION IS REQUIRED FOR ISSUANCE OF THIS PERMIT.
